ENGINEERING DIVISION - CAPITAL PROJECTS

The following are capital construction and design projects under the administration of the Engineering Division and their present status. This covers approximately the next 6 months.

NC-1129000– Orange County Streetcar

(DAI)

OCTA is constructing an at-grade streetcar from the Santa Ana Regional Transportation Center (SARTC) to the NE corner of Harbor Blvd & Westminster Ave. Construction underway.

- NTP: 3/4/19 Est. Project Completion: 2021
- Length: 4+miles

Grooved Cross Gutter Replacement (NICK)

There are currently 8 known grooved cross gutters at various locations around the city. These will be replaced with regular cross gutters and modifications to the existing streets to adjust surrounding grades.

- DESIGN COMPLETE. Construction will proceed as funding becomes available.
- Seven grooved cross gutters will be included in Ward Street Rehab project in 2021.

SANITARY SEWER

- **CP1165000 Sewer Main Replacement Project 1- Project #7840** – The Sewer Rehabilitation Plan Phase 1, Sewer Main Replacement Project 1 (at Euclid Street, Pinehurst Court, Nelson Street, Pine Street, Pearl Street, Allen Drive, Stanford Avenue, Euclid Park, Trask Avenue, and Wilson Street) is one of many projects designed to address defective sewer pipe throughout the City. The sewer improvements consist of approximately 30 feet of 6-inch diameter, approximately 5,440 feet of 8-inch diameter and, 1,290 feet of 12-inch diameter extra strength Vitrified Clay Pipe (VCP). It also includes the construction of 27 new manholes, modification of 2 existing manholes and 124 sewer house reconnections.

Project Limit: Throughout the City

Contractor: CHI Construction

Contract Amount: \$2,705,830

Working Days: 185

Status:

- Project is approximately 70% completed. Contractor will complete all sewer replacement in Stanford Ave this week. Contractor will be working in the remaining section after the New Year.

- **CP1141000 Partridge Lift Station Improvements Project** –The District has been experiencing frequent pump clogging caused by wet wipes from the tributary area. The District is considering to install a new grinder at the upstream of the lift station. Staff has hired AKM to provide a preliminary design of the grinder installation for the Partridge Lift Station.

Project Limit: Partridge Lift Station

Contractor: Pacific Hydrotech Corp

Bid Amount: \$614,900

Status:

- Contract has been awarded. Contractor will have the pre-construction meeting after the New Year.

WATER

- **CP1205000 Magnolia Reservoir and Booster Pump Station Rehabilitation Project (GG Project #7402)** – The reservoir repairs consist of crack and joint repair, construction of seismic curb, roof waterproofing, rust spot repair, and the addition of a fall protection system. The repair work for

the pump station consists of replacement of the existing engine and booster pump, replacement of the existing exhaust system, replacement of the existing catalytic converter, replacement of two 10-inch butterfly valves, replacement of the 10-inch check valve, refurbishment of the existing flow control valve, and replacement of the roof and existing removable dormer.

Project Limit: Magnolia Park (No traffic impact).
Contractor: Pacific Hydrotech Corp.
Bid Amount: \$3.2 M

Status: Contract has been awarded. Pre-construction meeting has been held on 12/16/2020. We will notify Community and Economic Development when construction will begin (most likely in the summer time)

SANITARY SEWER

- **CP1244000 Sewer Main Replacement Project 2&3**—The Sewer Rehabilitation Plan Phase 1, Sewer Main Replacement Project 2 (at Galway Street, Gilbert Street, Kerry Street, Kellogg Way, Alley near Belfast Drive, Crosby Ave, Central Avenue, and Acacia Avenue) and Project 3 (Trask Avenue, Edgebrook Drive, Garden Grove Boulevard, and Sycamore Street) are two of many projects designed to address defective sewer pipe throughout the City. The sewer improvements will consist of approximately 4,400 feet of sewer pipes, includes both design and optional construction management/inspection services.

Project Limit: See Location Map
Consultant: JIG
Status:

- Consultant finalizing the design for the Garden Grove section while continue to work on 90% submittal on the remaining portion.

- **CP1245000 Sewer Main Lining and Spot Repairs Projects 3&4**—This project consists of rehabilitating approximately 22,813 linear-feet of 8-inch & 10-inch sewer using UV-Cured Glass Reinforced Plastic cured-in-place liner. The project will be at various locations throughout the City. The project will also include spot repairs, sewer lateral reinstatements and top hat sewer lateral seals. The project includes both design and optional construction management/inspection services.

Project Limit: See Location Map
Consultant: Gannett Fleming, Inc.

Status:

- Consultant submitted the 60% design. Staff is reviewing the plans.

- **CIP Project 92 (Donegal Drive Sewer - GGSD Project #7835)** – GGSD Board awarded a design contract to JIG Consultants on 1/26/2016. Kick-off meeting was held on 3/10/2016.

Project Limit: Donegal Drive (Medison Cir. to Bolsa Ave.)

Status:

- The consultant has completed approximately 60% of the design. Alternate alignment required due to the portion of the existing alignment being sandwich between block wall and houses.

WATER

- **OCWD PFAS Final Treatment Design** – CDM Smith is one of the 6 consultants that OCWD has retained to perform final design for well head treatment of the City's 7 affected wells. Ion Exchange has been selected as the preferred treatment approach for all the well sites due to space constraint.

Project Limit: Well 19, Well 29, Well 30, Lampson Reservoir and Booster Station, West Haven Reservoir and Booster Station

Consultant: OCWD – CDM Smith

Status:

- OCWD has advertised the project on December 18, 2020. Bid Opening is set for February 2, 2020.

- **SCADA Implementation Project** – The SCADA Master Plan has recommended 22 projects to be implemented over a 5-year period. The City is seeking for Program Management Services to facilitate the detailed design and implementation of these recommendations.

Project Limit: At the various water distribution facilities

Consultant: West Yost Associates

Status:

- Consultant working on the Foundational Projects which includes hardware, software, and network design, SCADA Standardization, global operation improvement, global pressure monitoring improvement, and policies and procedures.

- **Public Works Yard Block Wall** – Civiltec Engineering has completed the design. Building Department reviewed and approved the plans.

Project Limit: Within the existing facility (No traffic impact).

Status:

- This project will be packaged with one of the water facility projects in the future.

SANITARY SEWER SHARED

City of Anaheim

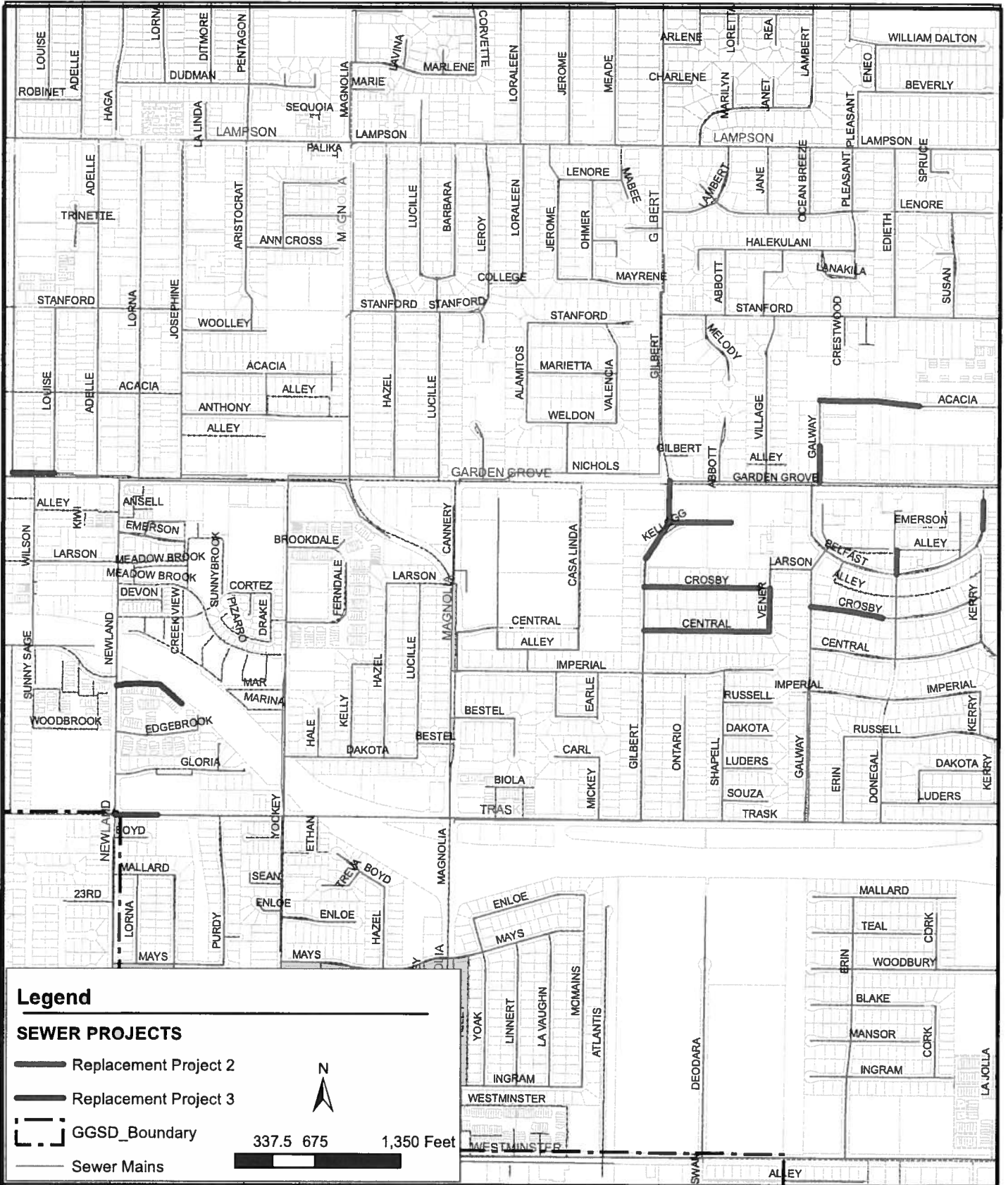
- Anaheim continues to resist updating 1986 Shared Sewer Agreement. The main stumbling block is that they do not want to lower the current d/D ratio of 0.75.

City of Santa Ana

- Santa Ana has agreed to include GGSD's portion of Westminster Sewer upgrade in their design and construction. Santa Ana City Council and GGSD Board have approved the reimbursement agreement between the City of Santa Ana and GGSD for this project.
- Santa Ana and GGSD staff agreed on the areas and contents of the shared sewer agreement. The final draft has been reviewed by attorneys. Santa Ana City Council approved the shared sewer agreement in August 2017. GGSD Board approved the agreement in October 2017.





City of Orange

- Water Services has initiated the conversation with City of Orange to draft a share sewer agreement. We have researched with the City Clerk to see if there is any existing share sewer agreement. The City Clerk did not find any.

County of Orange Advisory Regarding Moderna Vaccine Lot 041L20A

Santa Ana, Calif. (January 18, 2021) – Based on directive from the State, the Orange County Health Care Agency (HCA) has suspended the use of Moderna COVID-19 vaccine lot 041L20A due to possible allergic reactions under investigation by the Centers for Disease Control and Prevention (CDC), U.S Food and Drug Administration (FDA), and the manufacturer. To date, the HCA has received zero notifications of allergic reactions requiring medical attention due to any Moderna vaccines.

According to the State vaccine registry, 5,217 individuals in Orange County received the Moderna vaccine lot 041L20A. To determine if you received the subject vaccine lot, please refer to your vaccination card. If you received a vaccine from this lot number and experience any adverse reactions or don't feel well, please immediately contact your primary care provider/doctor.

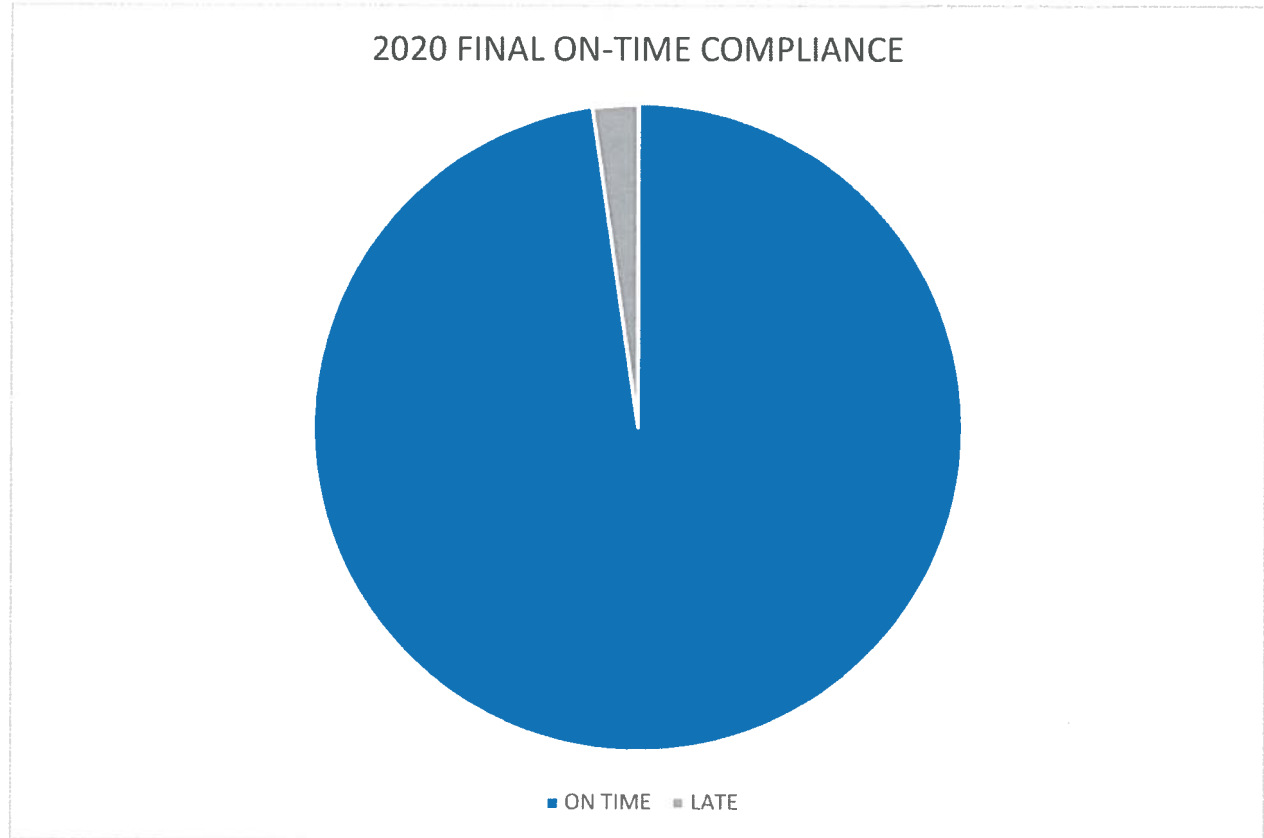
The HCA and healthcare providers throughout the County continue to schedule appointments and distribute vaccines to those who qualify in Phase 1A, all tiers. There are currently more than 250,000 individuals registered in Othena. Based on their priority level, people will be notified by email or text to schedule their appointments when their turns come up to get the vaccines.

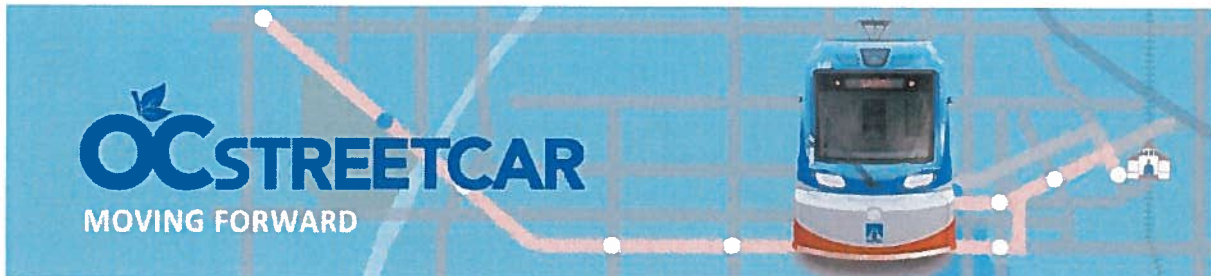

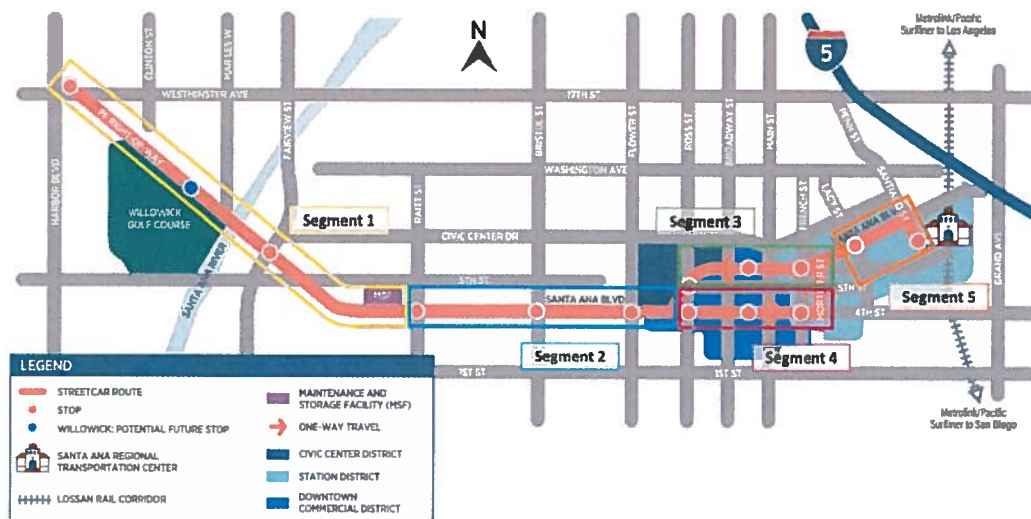

Construction Highlights:

- Full intersection closure at Raitt Street and W. Santa Ana Boulevard. Detour routes will be in place.
- Streetcar track installation in Segment 2. This work requires full lane and parking closures on Santa Ana Boulevard from Raitt Street to Shelton Street. Detour routes are in place.
- Streetcar track installation in Segment 3. This work requires full lane closures on Santa Ana Boulevard from Parton Street to Mortimer Street. A single lane is open for through traffic.

Access will be maintained for all residents and businesses. Construction activities are dependent on weather and resource availability.

For specific work activities in your area, see the segment overviews below.



SEGMENT 1 CONSTRUCTION ACTIVITIES

Intersection of Harbor Blvd. and Westminster Ave. to Raitt St.

Over the next two weeks, Segment 1 construction activities will include:

- Maintenance Storage Facility construction
- Westminster Avenue Bridge construction
- Sidewalk and median work on Westminster Avenue
- Base installation for overhead wire poles and storm drain installation along the Pacific Electric Right-of-Way (PEROW)
- Water pipeline installation on 5th Street from English Street and Fairlawn Avenue
- Foundation and platform work for the Fairview Street station and the Raitt Street station

SEGMENT 2 CONSTRUCTION ACTIVITIES

Raitt St. to Parton St.

Over the next two weeks, Segment 2 construction activities will include:

- Streetcar track installation on W. Santa Ana Boulevard from Raitt Street to Shelton Street
- Sidewalk work at the Western Avenue and Forest Avenue intersections

Rolling, 48-hour driveway closures on the north side of W. Santa Ana Boulevard from Raitt Street to Pacific Avenue will be in place starting January 18. A designated parking area in front of Carver Elementary School and on the south side of W. Santa Ana Boulevard is available while driveways are closed.

The north side of W. Santa Ana Boulevard is closed from Raitt Street to Pacific Avenue for streetcar track installation. One lane of eastbound traffic is open and westbound traffic is detoured at Bristol Street. Parking is closed on the north side of W. Santa Ana Boulevard. Please follow parking rules as posted to avoid towing.

The W. Santa Ana Boulevard and Raitt Street intersection is closed for streetcar track installation. Detour routes are available on 1st Street to Western Avenue or on 5th Street to Bristol Street.

SEGMENT 3 CONSTRUCTION ACTIVITIES

Ross St. to Mortimer St.

Over the next two weeks, Segment 3 construction activities will include:

- Streetcar track installation on W. Santa Ana Boulevard from Parton Street to Mortimer Street
- Sidewalk work at the Sycamore Street, Bush Street, Spurgeon Street and French Street intersections

Two lanes on W. Santa Ana Boulevard from Parton Street to French Street are closed for streetcar track installation. One lane of eastbound traffic is open. The intersections at W. Santa Ana Boulevard and Sycamore Street and at E. Santa Ana Boulevard and Bush Street are partially closed.

SEGMENT 4 CONSTRUCTION ACTIVITIES Ross St. to Mortimer St.

No construction activities are anticipated in Segment 4 over the next two weeks.

SEGMENT 5 CONSTRUCTION ACTIVITIES Mortimer St. to SARTC

No construction activities are anticipated in Segment 5 over the next two weeks.

25-year veteran Garden Grove police officer dies of COVID-19

A 25-year of the veteran of the Garden Grove Police Department died early Sunday, Jan. 17, more than a month after he contracted COVID-19.

Lt. John Reynolds contracted the virus in late November, and was 59 years old at the time he was pronounced dead due to complications associated with the disease, Garden Grove

police said in a news release. Reynolds is survived by his wife, Jena, as well as their two adult daughters and an 18-month old son.

He worked his way up from the patrol division, serving as a gang officer, SWAT team member, undercover investigator and Sergeant of the GGPD's Youth Services Unit before he was promoted to Lieutenant in 2018. His dedication to youth outreach led him to a seat on the exec-

utive board of the Garden Grove Boys and Girls Club. He was also an active volunteer with the Kiwanis Club of Greater Garden Grove.

The Garden Grove Chamber of Commerce named Reynolds "Man of the Year" in 2019. The longtime public servant was recognized by his department as Officer of the Year in 2005 and 2006, and earned the Garden Grove Medal of Merit in 2014 for his work Gar-

den Grove Unified School District in 2014.

The GGPD, Orange County District 1 Supervisor Andrew Do and Garden Grove City Councilman George Brietigam thanked Reynolds for his contributions to the community. They also extended condolences to his loved ones.

"His loss will be felt by so many who knew him as a generous man and a pillar of his community," Do said on social media Sunday.

Shooting in Garden Grove hotel leaves one dead; police seek clues to suspect

A man was shot in the head near the lobby of a Garden Grove hotel early Sunday morning, police said.

The shooting occurred on the west side of the Hyatt Regency Hotel at around 3:48 a.m., Garden Grove police said in a statement.

When officers arrived, they found the victim

down in the hallway, and transported him to a hospital, where he died. He was only identified as a 28-year-old man.

Police believe the shooter fled through the hotel parking lot. He has

not been found.

There was little information about the shooting Sunday. Police did not have a description of the suspect. A Garden Grove homicide detective declined to comment.

Appeal by 4 OC cities denied

Effort aimed to increase future Santa Ana housing requirement while decreasing their own

Four Orange County cities lost appeals Friday in seeking to increase the number of homes Santa Ana must plan to build in the coming decade.

The cities of Garden Grove, Irvine, Newport Beach and Yorba Linda lost their appeals during a hearing held by the Southern California Association of Governments.

The board nixed the four cities' appeals, which asked the state to increase the number of homes allocated to neighboring Santa Ana; they are also asking to decrease their own numbers. Officials from the cities asked Southern California's regional planning agency to, among other things, take into account the number of Santa Ana apartments already planned for construction as meeting future housing needs.

Santa Ana Councilman Phil Bacerra, who said his city has long championed affordable housing, was pleased with the outcome.

"We've demonstrated a commitment to doing our part in addressing California's housing crisis by efficiently using our land for housing purposes," Bacerra said. "It's about time other cities take the same approach and do the same."

State law requires all California municipalities to revise their housing plans every five to eight years to accommodate future housing needs, as determined by the state Housing and Community Development Department.

State officials determined the region must plan for construction of 1.34 million new homes from October 2021 through October 2029 — triple the

current goal for a planning period that ends this year.

Cities now are appealing to reduce their share of that regionwide allocation.

However, the appeals involving Santa Ana are the only ones seeking an increased allocation for a Southern California city, and the only ones in which one city sought to change a neighbor's numbers.

Garden Grove Councilwoman Kim Nguyen ar-

gued that it's not Santa Ana that is getting dumped on but the surrounding cities.

Santa Ana and four other cities — Anaheim, La Habra, Orange and Stanton — were able to reduce their required new housing numbers because they qualified as having "disadvantaged communities." That led to a redistribution of 44,514 housing units to surrounding cities, Garden Grove officials wrote in their appeal.

"Garden Grove received over 4,000 from that bucket," Nguyen said.

"The methodology used

for the allocation goes against their intended priority for housing as well as disproportionately affects cities like Garden Grove, which (also) has a high number of residents living in disadvantaged communities," she said.

Garden Grove, meanwhile, is considered 48% disadvantaged, just 2% shy of what would have qualified it for a reduction in its housing allotment, Nguyen said.

Garden Grove is expected to plan for construction of 19,122 housing units over the next eight

years. Irvine's housing goal is 23,554; Newport Beach's target is 4,834 and Yorba Linda's goal is 2,411. Santa Ana, meanwhile, was allocated 3,087 units as its goal by SCAG. (Garden Grove's appeal of its own number will be heard Jan. 22.)

Officials from the other four cities wanted SCAG to consider that Santa Ana has some 10,000 housing units in some phase of planning or development. Bacerra, the Santa Ana councilman, said they're trying to include homes that have not yet been built.

"We haven't even taken

our general plan to the planning commission, so for anyone to hang their hat on our plan, in draft mode, is wrong," Bacerra said. "It doesn't guarantee they will be all built or approved."

Santa Ana also is one of the densest cities not only in the state but in the nation, Bacerra said, arguing that his city already has done its share to build housing for different income levels.

Santa Ana Mayor Vicente Sarmiento said his city "will continue to do the right thing" by building

much-needed affordable housing. But, he added, "every Orange County city must do its part."

This year, 17 Orange County cities asked to have their numbers reduced. The four cities that hoped to increase Santa Ana's share have their own appeals scheduled, including Yorba Linda, which lost its appeal on Friday.

The next scheduled hearing is Tuesday for Fullerton, Laguna Hills, Fountain Valley, Huntington Beach, La Palma, Rancho Santa Margarita, Tustin, and Newport Beach.

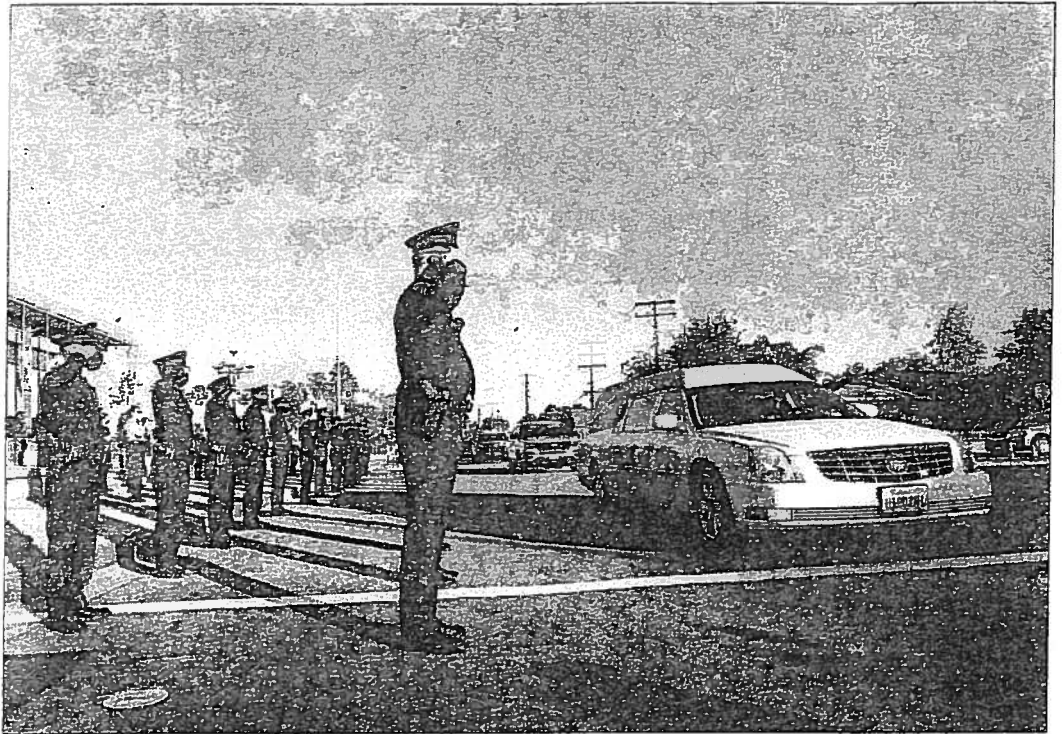

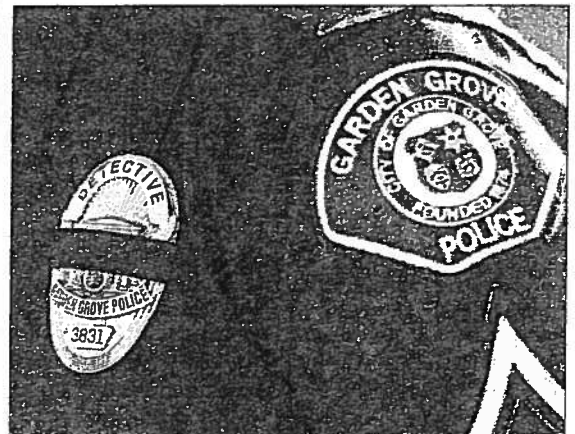

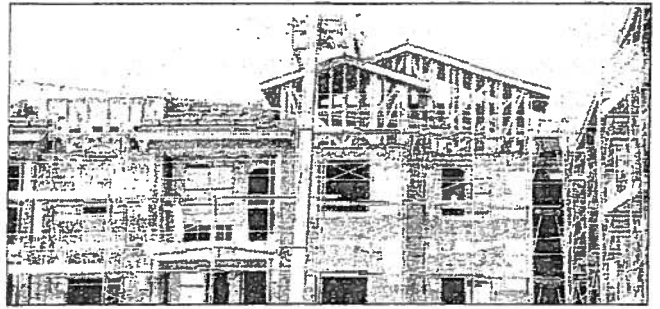

Slow to start, coronavirus testing in Orange County is going strong

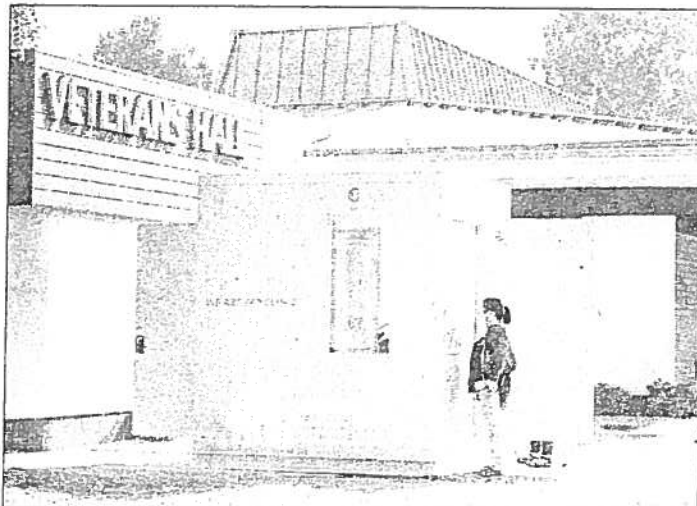
Once novel and hard to come by, coronavirus tests have become an essential part of pandemic life in Orange County and now can be found at doctors' offices and massive drive-thrus or ordered online for doorstep delivery.

This week, they'll even be available at John Wayne Airport — for a price — just before travelers pass through security. Results are supposed to be ready within half an hour.

About 10 months after the pandemic started in Orange County and public and private operations got off to a sputtering start, the countywide testing engine is humming, with more options — many of them free — and shorter turnaround times.

Swabbing noses and throats, drawing blood and, most recently, perusing saliva for traces of the virus have been a priority throughout the pandemic to help public health officials understand COVID-19's actual footprint at micro and macro levels.

"The county's testing ecosys-

tem includes our two super sites, several near-site community-based kiosks, and access to 1 million at-home test kits to assure supply meets the growing demand for COVID-19 testing," said Marc Meulman, chief of operations at the county Health Care

Agency's public health services.

Capacity has come a long way. Collective testing in the county surpassed 10,000 swab tests a week in the seven-day period that ended April 30.

The county now consistently

surpasses 100,000 swabs per week; one recent peak was about 169,000 Jan. 1-8.

Nearly 2.4 million swab and saliva tests have been conducted in OC, with an additional 109,000 serology tests, which are ordered to see if a person previously was infected by detecting virus-fighting antibodies in their blood.

Once behind in average tests conducted per person among all California counties, Orange County pulled ahead in October and has been in line with or above the state median since then.

Over the week that ended Jan. 2, the latest figures available from the state Department of Public Health, Orange County ran 570 tests per day per 100,000 residents, above the state average of 448.

That week, however, Orange County trailed all of its neighbors. Los Angeles County led the pack, conducting 801 tests per day per 100,000.

Demand for tests at the

county's two appointment-only drive-thru supersites — at the Anaheim Convention Center and the fairgrounds in Costa Mesa — has been higher than expected since Thanksgiving, said Linda Nguyen, community outreach director at 360 Clinic, which is under contract with the county to run the sites.

"We were not prepared for that surge. Of course, we expected a minor surge, but we were not expecting our operations to nearly double," Nguyen said.

Leading up to Thanksgiving, each site ran about 4,000 tests per day, she said. Then, Thanksgiving gatherings contributed to an end-of-year wave of new cases, and each drive-thru site ramped up to test about 7,000 people per day.

Still, patients are getting their results in about a day and a half, Nguyen said.

The testing company also runs about a dozen kiosks set up at city halls, parks, senior centers and other civic settings where demand is high in surrounding neighborhoods, including in Anaheim,

Buena Park, Garden Grove and Orange. Those booths can run about 500 tests per day, Nguyen said.

Waiting times at the supersites have improved as people who test frequently return and staffers aren't needed as often to walk patients through the process.

"I personally went through the line myself as a regular patient, and I was in and out of there within 20 minutes," Nguyen said, describing a visit this month.

However, Nguyen said, 360 Clinic plans to keep its sites by appointment only, having learned from a rocky experiment with allowing walk-up testing at a kiosk at Fountain Valley Sports Park last month. More people than expected showed up and the staff was overwhelmed.

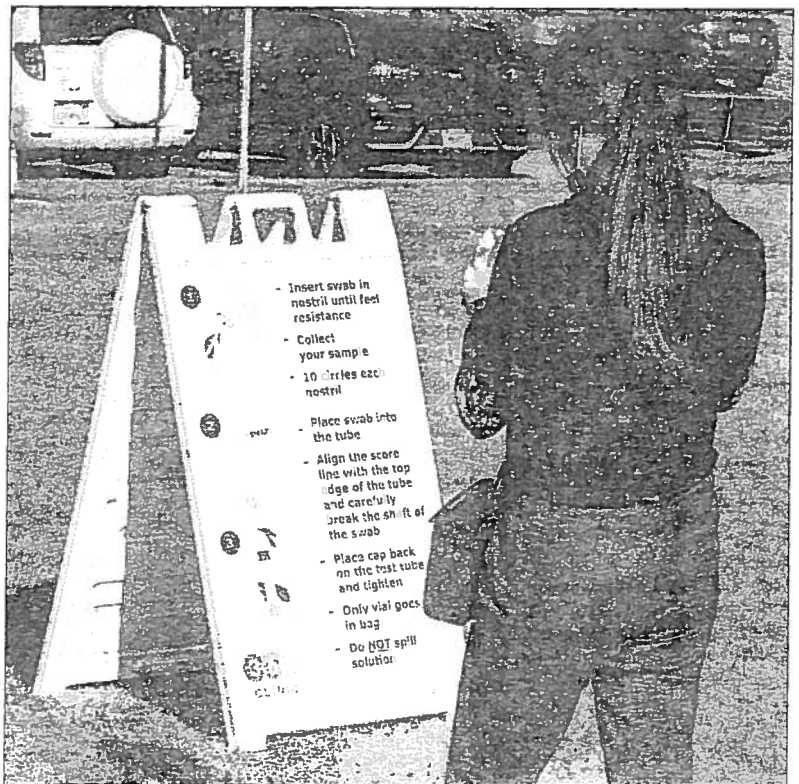
Though Orange County's vaccine rollout has begun, Nguyen expects demand for testing to remain high this year.

"Testing will continue in the year to come. ... We have a good amount of people who are not comfortable with the vaccine at this time," she said.

He was a consummate professional, a man of integrity, and a very dear friend who will be missed by all."

Cal Cities weekly COVID-19 update: Dec. 30-Jan. 6

January 6, 2021

Nearly 40 million Californians remain under the state's regional stay-at-home order, to further prevent the spread of the COVID-19 virus and avoid overwhelming hospitals so that more people may receive care.

Northern California is the only region in the state that currently has an ICU bed capacity above 15 percent and is not subject to the order.

Ahead of the Jan. 10 deadline to introduce a State Budget proposal, Gov. Gavin Newsom on Jan. 5 previewed a \$4.5 billion Equitable Recovery for California's Businesses and Jobs plan, which will be part of the 2021-22 State Budget and seek to help businesses and jobs affected by COVID-19. The stimulus program includes a variety of grants and tax incentives, many of which would require legislative approval to take effect. The Governor also requested immediate action items from the Legislature on Jan. 6 to approve \$600 rapid cash support to low-income Californians, and extend the statewide eviction moratorium which is currently set to expire on Jan. 31. More details on these plans, as well as the full State Budget proposal, are expected on Friday, Jan. 8.

On Dec. 30, the state released the California's Safe Schools for All plan, which is a statewide framework with the goal of supporting schools as they safely resume in-person instruction.

Governor Newsom's proposed 2021-22 State Budget prioritizes funding to support COVID-19 recovery effort, but lacks significant fiscal support for cities

January 8, 2021

Gov. Gavin Newsom unveiled Friday a record-breaking \$227.2 billion budget proposal for the 2021-22 fiscal year.

(updated on Jan. 13, 2021)

The proposed budget includes a \$164.5 billion General Fund and projects \$34 billion in total reserves and surplus. The budget significantly restores the state's rainy day fund, and economic support reserves that were diminished last year. A surplus of \$15 billion, largely in one-time funds, are available for spending to address COVID-19 and support resilience and recovery. During his press conference, the Governor said his budget proposal focused on the "most urgent needs" of Californians, including vaccinations, the safe reopening of schools, support for small businesses, money in the pockets of Californians, and wildfire preparedness.

The budget features the highest investment ever in public schools, \$4.5 billion to accelerate recovery and job creation in the state and \$370 million to expedite the delivery of COVID-19 vaccinations. The budget also includes \$1 billion to reduce wildfire risk and improve forest health, signaling continued focus on managing the state's growing wildfire threats amid the coronavirus pandemic and its economic fallout.

As part of his budget, the Governor is asking lawmakers to approve a roughly \$5 billion "early action" proposal, which includes \$2.4 billion to send \$600 payments to low-income families, \$2 billion to reopen schools, and nearly \$650 million in grants for businesses impacted by the pandemic.

Housing, Community and Economic Development

- Proposes to extend the evictions moratorium by an unspecified date to provide additional time to expend the \$2.6 billion in federal aid to assist low-income renters.
- Creates a new Housing Accountability Unit within the Department of Housing and Community Development (HCD) to provide technical assistance, monitor cities land use practices, and enforce existing housing laws. Provides \$4.3 million for technical assistance.

- \$2 million to the Department of Fair Employment and Housing to conduct education campaigns, housing surveys, and prosecute violations of California's fair housing laws.
- \$500 million to the Infill Infrastructure Grant Program, which provides grants to local governments and developers to spur housing construction.
- \$500 million to the Low-Income Tax Credit Program, which helps fund affordable housing projects.
- \$8.5 million to the California Workforce Development Board to expand state-approved construction apprenticeships.
- \$2.7 million to HCD to implement AB 434 (Daly, Statutes of 2020), which streamlines multiple housing programs into one application.
- \$750 million to expand Homekey, which provides grants to local governments to acquire and rehabilitate housing, including hotels and motels, to convert them into interim or long-term housing.
- \$750 million, over three years, to the Department of Health Care Services to provide grants to counties for behavioral health treatment resources.
- \$250 million to the Department of Social Services for acquisition and rehabilitation of Adult Residential Facilities and Residential Care Facilities to expand housing for low-income seniors.

Environmental Quality

- \$1.3 billion Cap-and-Trade expenditure plan that includes funding for safe drinking water, electric vehicle deployment, community air quality protection, and forest health management.
- \$1 billion to support the Forest Management Task Force's Wildfire and Forest Resiliency Action Plan, including:
 - \$323 million for proposed early action to accelerate fire prevention projects.
 - \$50 million for the Climate Catalyst Fund within the California Infrastructure and Economic Development Bank to support climate smart agriculture loans to advance climate change-related projects including methane reduction and circular economy projects.
 - Funding for forest health, urban forestry, fire prevention grants, and home hardening programs.
- \$256 million to the California Office of Emergency Services to fund the California Disaster Assistance Account. These funds assist local governments to serve their communities in the wake of emergency events.
- \$5 million to expand pilot programs to increase consumer redemption in communities underserved by recycling centers.

Revenue and Taxation

- \$2.4 billion for an additional \$600 state payment to low-income workers, which may have downstream positive effects on local revenue from increased consumer spending.
- \$575 million for small businesses and non-profit grants.
- Proposes significant tax credits/exclusions that may impact local sales and property tax revenues, including those for advanced energy projects and zero-emission vehicle charging stations.

Transportation, Communications, and Public Works

- \$2.4 billion for the State Transportation Improvement Program, which provides funding for future multimodal transportation improvements.
- \$1.5 billion for infrastructure and incentives to support the implementation of the state's zero-emission targets, with \$1 billion in future revenues for electric vehicle charging and hydrogen fueling stations, and \$465 million in Cap-and-Trade funding to improve access to new and used zero-emission vehicles.
- Forecasts fuel excise tax revenues are expected to be lower than pre-pandemic forecasts by a total of \$1.5 billion through 2024-25.
- \$1.3 billion to support transit and rail, including \$667 million in State Transit Assistance,
- \$1 billion to address traffic congestion, \$900 million to provide projects that support walking and biking and \$800 million for partnerships with local transportation agencies.
- \$487 million for Transit and Intercity Rail Capital Program, and \$107 million for the Low Carbon Transit Operations Program.
- \$353.9 million over the next five years for broadband infrastructure improvements and systemwide technology investments.
- \$52 billion in state infrastructure investments.

Governance, Transparency and Labor Relations

- \$14.4 million and 70 positions for the Division of Occupational Safety and Health to hire additional workplace safety inspectors.
- \$8.6 million and 43 positions to enforce recently enacted legislation to enhance workers' compensation access for public safety and healthcare workers.
- \$5.5 billion one time for the statutorily required pension contributions on behalf of the state and an additional \$1.5 billion to reduce the state's unfunded liability.
 - There is no proposal or funding proposed to assist public agencies with their pension or retiree health care costs.

Public Safety

- Significant investments to enhance the Department of Forestry and Fire Protection's fire prevention and suppression capacity:
 - \$2.9 billion for 8,735.1 positions
 - \$143.3 million for additional fire crews

- \$48.4 million to support the phasing in of new firefighting aircrafts
- \$323 million for early action in the spring to accelerate wildfire prevention projects before next fire season.
- \$153.8 million in the Cannabis Control Fund to reflect the consolidation of the functions and positions of the Bureau of Cannabis Control, the Department of Food and Agriculture, and the Department of Public Health into a new stand-alone Department of Cannabis Control within the Business, Consumer Services, and Housing Agency on July 1, 2021.
- Increases Proposition 64 allocation by \$146.2 million, with an estimated \$443.1 million available for youth education, prevention, early investment, treatment, environmental impacts of illegal cannabis cultivation, and other public safety-related activities.
- \$72.2 million in ongoing General Fund dollars, an increase of 3.7 percent from the 2020 Budget Act, to assist courts in continuing to provide fair and timely access to justice during COVID-19.
- \$13.5 million ongoing to the Department of Justice to create three teams to investigate officer-involved shootings that result in the death of an unarmed civilian.
- Proposes closing a second state-operated prison in 2022-23. California Department of Corrections and Rehabilitation is already planning to close Deuel Vocational Institution (Tracy, CA) by Sept. 2021, achieving savings of \$113.5 million General Fund in 2021-22, and \$150.6 million General Fund beginning in 2022-23.

Community Services

- \$3.1 billion in local assistance funding for various child care programs.
- \$82 million to support the 'Parks for All' initiative.
- \$25 million to continue the Great Plates Delivered senior meals program.
- \$5 million to implement the Master Plan for Aging in 2021.
- \$5 million to provide grants to local libraries to support early learning and after-school programs.
- \$1 million to support the online purchase and delivery of library books through the Zip Books program.

Proposed 2021-22 State Budget includes investment in climate resiliency, but limited direct funding for cities

January 13, 2021

Gov. Gavin Newsom's sweeping \$227 billion proposed 2021-22 State Budget includes a number of climate resiliency-related items, ranging from wildfire preparedness to electric vehicle deployment.

Due to an unexpected budget windfall of approximately \$15 billion, largely in one-time funds, the Governor is putting some of these funds towards supporting climate resilience and recovery.

In keeping with his priorities from the past several years, the Governor indicated that wildfire preparedness, which he frames as climate resiliency, will continue to be a budgetary priority. However, unlike previous years, local governments are not receiving the same type of environmental and climate resiliency funding they have in the past. Due to the projected budgetary future, many environmental programs are funded on a one-time, rather than continuous basis.

Overall, the Governor's climate resiliency budget priorities center on wildfire preparedness and forest management, and electric vehicle deployment. While investments in these areas help make the state more resilient to climate change, there is little to no money included in the proposed budget that goes directly to local governments to address issues like sea level rise or implementing climate change adaptation projects. Below, Cal Cities has outlined the various pots of funding related to climate resiliency that pertain to cities.

Cap-and-Trade

The Governor's budget proposes a \$1.37 billion Cap-and-Trade expenditure plan, which is up slightly from the \$965 million expenditure plan proposed in January 2020. This expenditure plan includes \$30 million for safe and affordable drinking water, \$635 million for the Governor's electric vehicle deployment plan, \$325 million for community air quality protection, and \$355 million for forest health management. In recent years, Cap-and-Trade has included funding for California Department of Resources Recycling and Recovery (CalRecycle) to meet the state's waste diversion goals. This year, that pot of funding is not included in the Cap-and-Trade expenditure plan, but is included in the Governor's Climate Catalyst Fund proposal.

Forest Management Task Force – Wildfire and Forest Resiliency Action Plan

In 2020, the Legislature and Governor included approximately \$90 million for the California Department of Forestry and Fire Protection (CAL FIRE) to enhance their fire protection capabilities

capacities.

This year, the Governor is proposing another significant investment in CAL FIRE by proposing \$1 billion to support the Forest Management Task Force's Wildfire and Forest Resiliency Action Plan. This plan touches on numerous items, ranging from forest health and management to building fire breaks and creating home hardening grant programs.

This action plan includes:

- \$512 million for resilient forests and landscapes, including \$23 million for urban forestry
- \$335 million for wildfire fuel breaks
- \$38 million for community hardening, including \$25 million for home hardening grants
- \$39 million for science-based management
- \$76 million for forest sector economic stimulus, including \$50 million for the Climate Catalyst Fund within the California Infrastructure and Economic Development Bank (IBank) to support climate smart agriculture loans to advance climate change-related projects

Out of this \$1 billion plan, \$323 million is proposed for early action in 2020-21 to accelerate fire prevention projects that protect communities and other efforts to jumpstart economic recovery in the forest sector.

Climate Catalyst Fund

In 2020, the Governor's January budget proposal unveiled an ambitious new program called the "Climate Catalyst Fund," with the intent to fund programs to address transportation emission reductions, climate smart agriculture and forestry, and circular economy development and implementation. Due to COVID-19-inflicted budgetary strains, the fund was created, but no money was appropriated into the fund. This year's budget proposal includes close to \$1 billion in funding for two programs to further these goals.

Fifty million is proposed for the IBank to support climate smart agriculture loans to advance projects, such as methane reduction, water efficiency, healthy soils, circular economy development, and energy efficiency for food processing. Of note, the Governor's Administration has indicated that this pot of funding could be used for infrastructure projected, related to the implementation of [SB 1383 \(Lara, 2016\)](#) organic waste diversion mandates.

Additionally, \$47 million of the approximately \$1 billion allocated to the Climate Catalyst Fund is for the wildfire and forest resilience package outlined in this article.

Recycling

This year's budget proposal includes \$5 million to CalRecycle to expand pilot programs to increase consumer redemption in communities underserved by recycling centers. With many recycling centers closed in recent years, this funding is much needed to address the lack of redemption

centers in California.

Disaster and Emergency Preparedness

With California continuing to face COVID-19 and the threat of catastrophic wildfires, the Governor's budget proposes \$256 million to the California Office of Emergency Services (Cal OES) to fund the California Disaster Assistance Account (CDAA). The CDAA assists local governments to serve their communities in the wake of emergency events. This funding will go towards repairing, restoring, or replacing public real property damaged or destroyed during a disaster or to reimburse local governments for certain costs associated with the emergency activity undertaken.

Additionally, \$67 million this fiscal year and an additional \$158 million over the next three years is proposed to fund a large federal flood risk reduction project along the American River. The Governor is also proposing \$75 million for deferred maintenance on levees in the Central Valley.

Lastly, the Governor proposes \$25 million in 2020-21 for Cal OES and CAL FIRE to support implementation of a home hardening pilot grant program. These funds would go to basic retrofits for homes of low-income Californians who live in high fire threat areas.

EV Charging

The budget proposal includes \$1.5 billion for infrastructure and incentives to support the implementation of the state's zero-emission targets. Specifically, \$1 billion in future revenues for electric vehicle charging and hydrogen fueling stations, and \$465 million in Cap-and-Trade funding to improve access to new and used zero-emission vehicles.

The budget also proposes statutory changes to extend existing vehicle registration fees currently set to expire in 2024 under [AB 8 \(Perea, 2013\)](#) and authorize the securitization of these future revenues to support the expansion of the California Energy Commission's Clean Transportation Program.

Cal Cities weekly COVID-19 update: Jan. 7-13

The California Department of Public Health announced on Jan. 12 that effective immediately, the Greater Sacramento region meets the criteria to exit the regional stay-at-home-order.

Counties in this region will immediately return to their appropriate tiers based on cases and test positivity rate.

On Jan. 8, Gov. Gavin Newsom released his proposed 2021-22 State Budget, which prioritizes funding to support COVID-19 response and recovery, but lacks significant fiscal support for cities. The proposed budget includes \$370 million to expedite vaccine delivery, and the Governor is asking lawmakers to approve a roughly \$5 billion “early action” proposal, which includes \$2.4 billion to send \$600 payments to low-income families, \$2 billion to reopen schools, and nearly \$650 million in grants for businesses impacted by the pandemic.

Following the release of the budget proposal, League of California Cities Executive Director and CEO Carolyn Coleman released a statement calling on the state to prioritize investments in cities to ensure a successful and equitable economic recovery for all Californians.

Local governments victorious in U.S. Supreme Court case involving impounded vehicles and bankruptcy proceedings

January 20, 2021

The U.S. Supreme Court ruled last week that a city's refusal to return an impounded vehicle to a debtor who files for bankruptcy is not a violation of the "automatic stay" provision of the federal Bankruptcy Code.

The court's opinion in *City of Chicago, Illinois v. Fulton* overturns an earlier ruling by the U.S. Court of Appeals for the Seventh Circuit previously highlighted by the League of California Cities.

The ruling is good news for local governments. The "automatic stay" provision of the Bankruptcy Code states that a bankruptcy petition "operates as a stay, applicable to all entities, of ... any act to obtain possession of property ... or to exercise control over property of the estate." The debtor in this case argued that this meant that the city was required to immediately return an impounded vehicle once the bankruptcy petition was filed.

The Supreme Court disagreed with the debtor's interpretation. The Court held that "mere retention" of a debtor's property after a bankruptcy petition is filed doesn't violate the automatic stay. According to Justice Alito, "the most natural reading of ... 'stay,' 'act,' and 'exercise control' — is that [the automatic stay provision] prohibits affirmative acts that would disturb the status quo of estate property as of the time when the bankruptcy petition was filed."

In a concurring opinion, Justice Sotomayor agreed that "the city's policy of refusing to return impounded vehicles satisfies the letter of the code," but noted that "it hardly comports with its spirit." Justice Sotomayor opined that the city may have violated a number of other provisions of the Bankruptcy Code, and that "bankruptcy courts are not powerless to facilitate the return of debtors' vehicles to their owners."

With the automatic stay issue now resolved, the case will be remanded back to the lower courts for further proceedings.

Cal Cities will continue to provide updates on important developments in the case. In the meantime, cities who have questions about how the Supreme Court ruling may impact their city are encouraged to consult with their city attorney.
